OVERVIEW

This website is operated by NEP Melbourne. Throughout the site and this document, the terms "Nep", "we", "us" and "our" refer to NEP Melbourne. Nep offers this website, including all information, tools and services available from this site to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.
